**PREPAID ELECTRIC SERVICE
SCHEDULE PE-6**

AVAILABILITY

Under schedule PE, Prepaid Electric Service, the Customer will pay for energy before it is consumed.

Available, on a voluntary and limited basis, to Cooperative Customers, subject to the Terms and Conditions of the Cooperative on file with the Virginia State Corporation Commission, and subject to the availability of the necessary automated metering infrastructure at the Customer's location. Schedule PE also shall be limited to the availability of appropriate meters.

Available, by request, to Customers of the Cooperative otherwise served under the Cooperative's Schedule R.

Schedule PE is not applicable to Customers using the Cooperative's Levelized Billing Plan, Automatic Bank Draft option, or Net Metering-Schedule NEM.

Schedule PE is not available to locations where the Customer is receiving, or begins receiving service subject to an active Serious Medical Condition Certification (SMCC) or where the service entrance size is greater than the rating of the Remote Disconnect Device.

TYPE OF SERVICE

Single-phase, 60 cycles, not to exceed 200 amp service at a secondary voltage of 120/240.

Recurring Charges

I. Distribution Delivery Charges:

Access Charge:

III. State and Local Taxes

Applicable taxes will be charged as required by State and Local codes. Any applicable minimum tax will be prorated and applied daily at an amount equal to such minimum tax divided by 30. Any tax calculated on a consumption basis will be applied daily based upon consumption occurring during the billing cycle.

BILLING DEMAND

The billing demand shall be the Member's maximum kilowatt integrated demand measured for any 60-minute clock hour period from 6:00 a.m. to 11:00 p.m. during the month for which the bill is rendered.

MINIMUM DELIVERY CHARGE

The minimum daily delivery charge shall be the Daily Access Charge under Part I of the Rate above.

POWER COST ADJUSTMENT

The amount of the charges calculated under the above rates for Electricity Supply Service is subject to increase or decrease under provisions of the Cooperative's Power Cost Adjustment Clause, Schedule PCA.

TERM OF CONTRACT

Service under Schedule PE shall be for one (1) year, automatically renewing and continuing from year-to-year, subject to suspension as described herein.

Effective: For bills rendered on and after January 1, 2023
